# Grace and peace to you in Christ Jesus, God Incarnate!

On the night when He was betrayed, Jesus declared to His disciples, "If I had not done among them the works which no one else did, they would have no sin; but now they have seen and also hated both

#### Ahonen called to serve as Deacon for Salem Lutheran Church

In our January voters meeting, there was discussion of calling Rev. Jeffrey Ahonen to the position of ordained Deacon, thus extending to him a valid call to the holy ministry so that he would begin his mission work, and also fill Salem's need for pastoral care during Pastor Heiser's vacations. The decision was made in our January meeting to schedule a special voters meeting February 4<sup>th</sup> to consider extending such a call. The vote to extend the call to Rev. Ahonen was unanimous.

The position description of Deacon of Salem Lutheran Church, as presented to the Voting Members, is as follows:

This position would be a very Part-Time position and shall be paid on a per-service-rendered basis. (This means that the remuneration is limited to those occasions when he is serving at Salem, and is not a salary.)

The Deacon will be expected to:

- a. Travel to Salem Lutheran Church to Preach the Word and Administer the Sacraments during the Pastor's vacation Sundays (3).
- b. Consult with the Pastor before scheduling preaching engagements at other congregations.
- c. Maintain a good standing with the Pastor and the diocese.

#### The Deacon will be asked to:

- a. Within the time frame of the Deacon's visit, lead other appropriate scheduled church studies, meetings and functions.
- b. Endeavor to develop mission congregations.
- c. Enjoy the hospitality of members of Salem Lutheran Church including room, board, and transportation to the best of its members' abilities during those times when he is serving in Texas.

The Deacon will not be required to do any of the following:

- a. Pay for travel expenses.
- b. Attend the services of Salem Lutheran Church, other than those requiring his travel and services.
- c. Perform any service without adequate remuneration.

The call specifies up to \$600 per year in remuneration for filling in for Pastor Heiser, and up to \$750 for travel expenses.

## Rev. Ahonen's Visit to Salem

Following Salem's decision to extend him a call to serve as Salem's Deacon, Rev. Ahonen requested an opportunity to meet with interested members of Salem to discuss our expectations regarding this call, and for him to set forth some of his hopes



regarding various mission opportunities. He visited with us on the evening of February 19<sup>th</sup>. Between twenty and twenty-five members were in attendance.

Rev. Ahonen led a discussion of mission prospects in the northern Midwest. Based on his personal knowledge and ministerial experience and contacts with other pastors and congregations in the region, confessional Lutheran missions could be planted in a wide variety of locations in the Upper Peninsula of Michigan, Wisconsin, or Minnesota. Throughout the region, there is a heritage of "cultural" Lutheranism (family ties, etc.), but a great weakness of Lutheran substance. The primary issue at present is whether the Lord will open secular employment opportunities which would Rev. Ahonen the opportunity to engage in mission work in the region.

We had the chance to talk about sharing the Gospel—always a joy!—enjoyed a potluck together and celebrated Carl Payne's 73<sup>rd</sup> birthday. It was a good evening! Please keep Rev. Ahonen in your prayers as he seeks the Lord's will regarding this call.

## Maier Debunks the Lies about "the Jesus Family Tomb"

The following is an "open letter" from Rev. Dr. Paul L. Maier, a professor of ancient history at Western Michigan University and Lutheran theologian. Although it would be hard to describe Maier as a "confessional Lutheran," we have to appreciate his excellent analysis of the blasphemous trash the Discovery Channel is running. The decision to air such antiChristian nonsense about our Lord during the season of Lent is all the more clearly an overt attack on the faith. The Church rejoices that the eternal Son of God became Man, and suffered, died and rose again for our salvation—this is the truth, and Satan's lies can never overturn the precious Good News of the Gospel.

#### Dear Friends and Readers,

Thanks for the profusion of e-mails I've received over the last two days regarding the Talpiot tombs discovery in Jerusalem, a.k.a., "the Jesus Family Tomb" story. Some of you also suggested that 'life seemed to be following art' so far as my A Skeleton in God's Closet was concerned. Believe me, this is not the way I wanted my novel to hit the visual media!

Alas, this whole affair is just the latest in the long-running media attack on the historical Jesus, which I call "More Junk on Jesus." We all thought it had culminated in that book of falsehoods, *The Da Vinci Code*. But no: The caricatures of Christ continue.

Please, lose no sleep over the Talpiot "discoveries" for the following reasons, and here are the facts:

- (1) Nothing is new here: Scholars have known about the ossuaries ever since March of 1980, so this is old news recycled. The general public learned about the ossuaries when the BBC filmed a documentary on them in 1996, and the "findings" tanked again. James Tabor's book, *The Jesus Dynasty*, also made a big fuss over the Talpiot tombs more recently, and now James Cameron ("Titanic") and Simcha Jacobovici have climbed aboard the sensationalist bandwagon as well. Another book comes out today, equally as worthless as the previous.
- (2) All the names' Yeshua (Joshua, Jesus), Joseph, Maria, Mariamene, Matia, Judah, and Jose' are extremely common Jewish names for that time and place, and thus nearly all scholars consider that these names are merely coincidental, as they did from the start. Some scholars dispute that "Yeshua" is even one of the names. One out of four Jewish women at that time, for example, was named Maria. There are 21 Yeshuas cited by Josephus, the first-century Jewish historian, who were important enough to be recorded by him, with many thousands of others that never made history. The wondrous mathematical odds hyped by Jacobovici that these names must refer to Jesus and His family are simply playing by numbers and lying by statistics.

- (3) There is no reason whatever to equate "Mary Magdalene" with "Mariamene," as Jacobovici claims. And so what if her DNA is different from that of "Yeshua"? That particular "Mariamme" (as it is usually spelled today) could indeed have been the wife of that particular "Yeshua," who certainly was not Jesus.
- (4) Why in the world would the "Jesus Family" have a burial site in Jerusalem, of all places, the very city that crucified Jesus? Galilee was their home. In Galilee they could have had such a family plot, not Judea. Besides all of which, church tradition and the earliest Christian historian, Eusebius of Caesarea, are unanimous in reporting that Mary, the mother of Jesus, died in Ephesus, where the apostle John, faithful to his commission from Jesus on the cross, had accompanied her.
- (5) The "Jesus Family" simply could not have afforded the large crypt uncovered at Talpiot, which housed, or could have housed, 200 ossuaries.
- (6) If this were Jesus' family burial site, what is Matthew doing there—if indeed "Matia" is thus to be translated?
- (7) How come there is no tradition whatever—Christian, Jewish, or secular—that any part of the Holy Family was buried at Jerusalem?
- (8) Please note the extreme bias of the director and narrator, Simcha Jacobovici. The man is an Indiana Jones wannabe who oversensationalizes anything he touches. You may have caught him on his TV special regarding *The Exodus*, in which he "explained" just about *everything* that still needed proving or explaining in the Exodus account in the Old Testament! It finally became ludicrous, and now he's doing it again, though in reverse—this time attacking the Scriptural record. As for James Cameron, how do you follow the success of *Titanic*? Well, with an even more "titanic" story. He should have known better, and the television footage of the two making their drastic statements on Monday, February 26, was disgusting, and their subsequent claim that they respected Jesus nauseating.
- 9) Even Israeli authorities, who—were they anti-Christian—might have used this "discovery" to discredit Christianity, did not do so. Quite the opposite. Joe Zias, for example, for years the director of the Rockefeller Museum in Jerusalem, holds Jacobovici's claims up for scorn and his documentary as "nonsense." Those involved in the project "have no credibility whatever," he added. Amos Kloner, the first archaeologist to examine the site, said the conclusions in question fail to hold up by archaeological standards "but make for profitable television." William Dever, one of America's most prominent archaeologists, said, "This would be amusing if it didn't mislead so many people."
- (10) Finally, and most importantly, there is no external literary or historical evidence whatever that Jesus' family was interred together in a common burial place anywhere, let alone Jerusalem. The evidence, in fact, totally controverts all this in the case of Jesus: All four Gospels, the letters of St. Paul, and the common testimony of the early church state that Jesus rose from the dead, and did not leave His bones behind

in any ossuary, as the current sensationalists claim.

Bottom line: This is merely naked hype, baseless sensationalism, and nothing less than a media fraud—"more junk on Jesus."

# Trinity Lutheran Prepares to Leave LC—MS

In the latest newletter of Trinity Lutheran Church (Herrin, IL), Pastor Michael D. Henson explains why the congregation will be leaving the LC—MS following this Summer's convention:

#### New Default Position

On January 9, 2005, Trinity Lutheran Church made the godly decision to stay in the Lutheran Church—Missouri Synod, follow the Synodical Dissent Process and fight for a return to the truth. At the same time we entered a State of Confession, in which we refused to commune with those who haven't renounced their Synod's public profession of these six points of false teaching. Since that time we have always maintained that should the July 2007 LCMS Convention not correct the six points of false teaching, which became the official position of our Synod at the 2004 LCMS Convention, we will be leaving her. We knew that a State of Confession could not go on indefinitely.

Well, the July 2007 LCMS Convention is only six months away. After speaking, writing, and distributing countless literature, I am pretty sure that most people in the LCMS simply don't care. Some embrace the new false teachings. Many don't personally agree with the changes, but they consider these things to be a matter of personal preference, not false teaching to be avoided. And finally, there are a small number of pastors (with unwilling congregations) and laymen (with unwilling pastors) who lament the changes but don't have many options. The various statements from official Synodical

publications and elected leaders make me assume that nothing is going to change. It appears that Synod will not return to her former Scriptural position regarding our six points.

Trinity Lutheran Church, pastors and members, will continue to follow the course we began two years ago, however. However with this newletter article, I will change from the default position of hoping that Synod will return to the new default position of assuming that Synod is not going to return. We will continue to follow Synod's procedure for dissent, including overtures to the 2007 LCMS Convention, but I want you to be ready for what appears quite likely. At this point, sad to say (for Synod, not for us), we need to be prepared to mark and avoid Synod as teaching falsehood (Rom. 16:17, 1 Tim. 6:3ff), and in accordance with Trinity's constitution, leave the Missouri Synod.

When I was asked by one of our Circuit's pastors whether the Synod and District were aware that we were preparing to leave the Synod, I told him that I was not saying anything different than I have said all along. We have sent letters to the Synodical President and the CTCR. We have spoken about this at District and Circuit meetings. From the floor of our District Convention in Feb of 2006 I stated, "Either Synod will return to her former teaching and we will drop our state of confession or Synod will continue her new direction and we will leave her." In reality, Synod has chosen to leave us and take a different road, while we are staying the course.

Later in the newletter, Pastor Henson answers the question, "How many 'Lutheran' synods (options) are there?," in part as follows:

... After these large synods, a few synods have a hundred or two congregations, but most have only 50 or less. I have not researched every one, but each one seems to have their own problems—Pentecostal/Charismatic practices, Eastern Orthodox leanings, Pietism and Moralism. So far the only option I am still considering is the "Evangelical Lutheran Diocese of North America" (ELDoNA). They are a group of pastors, all of whom have come out of the Missouri Synod. I attended their conference last June in Texas and was quite pleased.
